WHEREAS, Julio's journey with La Casa Norte began when he was invited to join the Board by Sol Flores, the organization's founding executive director, who recognized his leadership, passion, and steadfast commitment to equity, qualities that have since proven invaluable to the organization's mission and success; and

WHEREAS, Julio Rodriguez's legacy at La Casa Norte and across Chicago is one of courage, inclusion, and transformational leadership, with work that has improved countless lives and strengthened the social fabric of our city; now, therefore,

WHEREAS, Immigration agents have detained thousands of Chicagoans since January 2025, a significant majority of whom had no known criminal convictions or pending

charges, and many of whom were arrested without a warrant or probable cause, and were instead targeted based on the color of their skin, the languages they spoke, and the jobs they performed; and

WHEREAS, Neighbors across Chicago responded to these atrocities by organizing themselves into neighborhood-level rapid response networks to inform neighbors of their rights, patrol their neighborhoods for Department of Homeland Security/Immigration and Customs Enforcement (DHS/ICE) presence, and warn neighbors of DHS/ICE activity in their community; and

WHEREAS, In many cases, the presence of these neighbors prevented innocent Chicagoans from being abducted without cause, and in other cases, they were the reason that loved ones knew that their friend or family member had been abducted and had support in locating them; and

WHEREAS, Federal agents responded to these efforts with brutal force, tear gassing neighborhoods, crashing into vehicles, shooting one community member, detaining others who were engaging in their civil right to document and record law enforcement, targeting journalists, and threatening protestors exercising their First Amendment rights with legal action; and
