ROLL CALL

Ald. Cardona motioned to accept Ald. Gutierrez', Napolitano's, Mitts' & Manaa-Hoppenworth's remote participation, via Rule 59. The motion passed without objection.

Chairman Villegas noted that no written comments were received.
