On September 3, 2025, the Committee on Public Safety held a meeting in City Council Chambers, at 10:30 am.

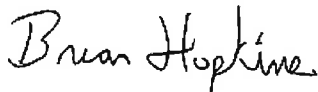

The Committee on Public Safety addressed the following matters:

- O2025-0018805: Assignment or reimbursement of Community Benefit Funds to The Magnificent Mile Association, named as the service provider for public safety improvements surrounding the Casino location. (RECOMMENDED DO PASS)
- R2025-0014883: Call for hearing(s) on alternative response model for parking violations. (NO VOTES TAKEN)
- SO2025-0017561: Amendment of Municipal Code Section 8-4-050, expanding the definition of trespassing and establishing cumulative fines from \$100 to \$1,000 depending on the section violated. (HELD in COMMITTEE)

Having no further business before the committee, Alderwoman Guitierrez motioned to adjourn at 12:22 pm.
