**COMMITTEE ON POLICE AND FIRE
MONTHLY RULE 45 REPORT
April, 2025**

Pursuant to Rule 45 of the City Council Rules of Order, the Committee on Police and Fire submits the following monthly report.

On Friday, April 11th, 2025, at 12:45 p.m., The Committee on Police and Fire called the meeting to order, pursuant to applicable law, the Chairman determined that remote participation was allowed in case of emergency, per the aldermen that requested. Accordingly, attendance at this meeting was in City Council Chambers, with some members participating virtually.

The following non-members were present: Burnett (27).

Chairman Taliaferro called the meeting to order at 12:43 pm. The Vice-Chair instructed protocol to be used in the forum. Roll Call was taken and a quorum was established.

Pursuant to Rule 59, Aldermen can request remote participation in extenuating circumstances. Alderman Mosley, Alderman Napolitano, Alderwoman Taylor, Alderman Mitchell, and Alderman Gardiner requested to participate remotely.
