By vote of 17 yays to 30 nays, the Committee on Committee and Rules voted not to re-refer O2024-0009676 to the Committee on Public Safety. Item did not pass.

*Item 2 – (O2024-0011032) Superintendent of Police directed to enter and execute new contract or contract or contract extension or renewal for acoustic gunshot detection technology services—was recommended to be re-referred to the Joint Committee on Public Safety and Committee on Police and Fire—there was a motion to “Lay on Table” by Alderman Reilly—motion passed by voice vote—item is held in committee.*

*Item 3 – (O2024-0010990) Amendment of Municipal Code Section 9-12-070 establishing maximum speed limit of 25 miles per hour on streets, 15 miles per hour in alleys, and absolute statutory nonurban limit of 55 miles per hour to be re-referred to the Committee on Pedestrian and Traffic Safety – moved to pass by Alderman LaSpata—**motion passed**.*

**Item 4:** (R2023-0005295) Resolution calling to rename conference room 201A as “The Honorable Harold Washington Meeting Room”, Aldermen Taliaferro, Lawson and Vasquez commented on this resolution – moved to pass by Alderman Clay – **motion passed**.
