Title:	Designation of 27th Precinct of 13th Ward as Restricted Residential Zone prohibiting additional shared housing units and vacation rentals

ORDINANCE

WHEREAS, Chapter 4-17 of the Municipal Code of Chicago authorizes the establishment of Restricted Residential Zones pursuant to an opt-out process, which requires a petition to trigger an ordinance; and

WHEREAS, The requisite procedural requirements have been met; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Sections 4-17-020 and 4-17-040 of the Municipal Code of Chicago ("Code"), the 27th Precinct of the 13th Ward, as described herein, is hereby designated as a Restricted Residential Zone within the meaning of Chapter 4-17 of the Code. All new or additional shared housing units and vacation rentals shall be prohibited within the boundaries of such 27th Precinct, with such boundaries beginning at the southeast intersection of South Lockwood Avenue and West 63rd Place, thence east on the south side of West 63rd Place to the east side of South Latrobe Avenue, then north on the east side of South Latrobe Avenue to the south side of West 63rd Street, thence east on the south side of West 63rd Street to the west side of South Lawler Avenue, thence southerly on the west side of South Lawler Avenue to the north side of West 64th Place, thence west on the north side of West 64th Place to the west side of South Leclaire Avenue, thence south on the west side of South Leclaire Avenue to the north side of West 65th Street, thence west on the north side of West 65th Street to the east side of South Lorel Avenue, thence north on the east side of South Lorel Avenue to the south side of West 64th Street, thence east on the south side of West 64th Street to the east side of South Lockwood Avenue, and thence north on the east side of South Lockwood Avenue to the place of beginning.

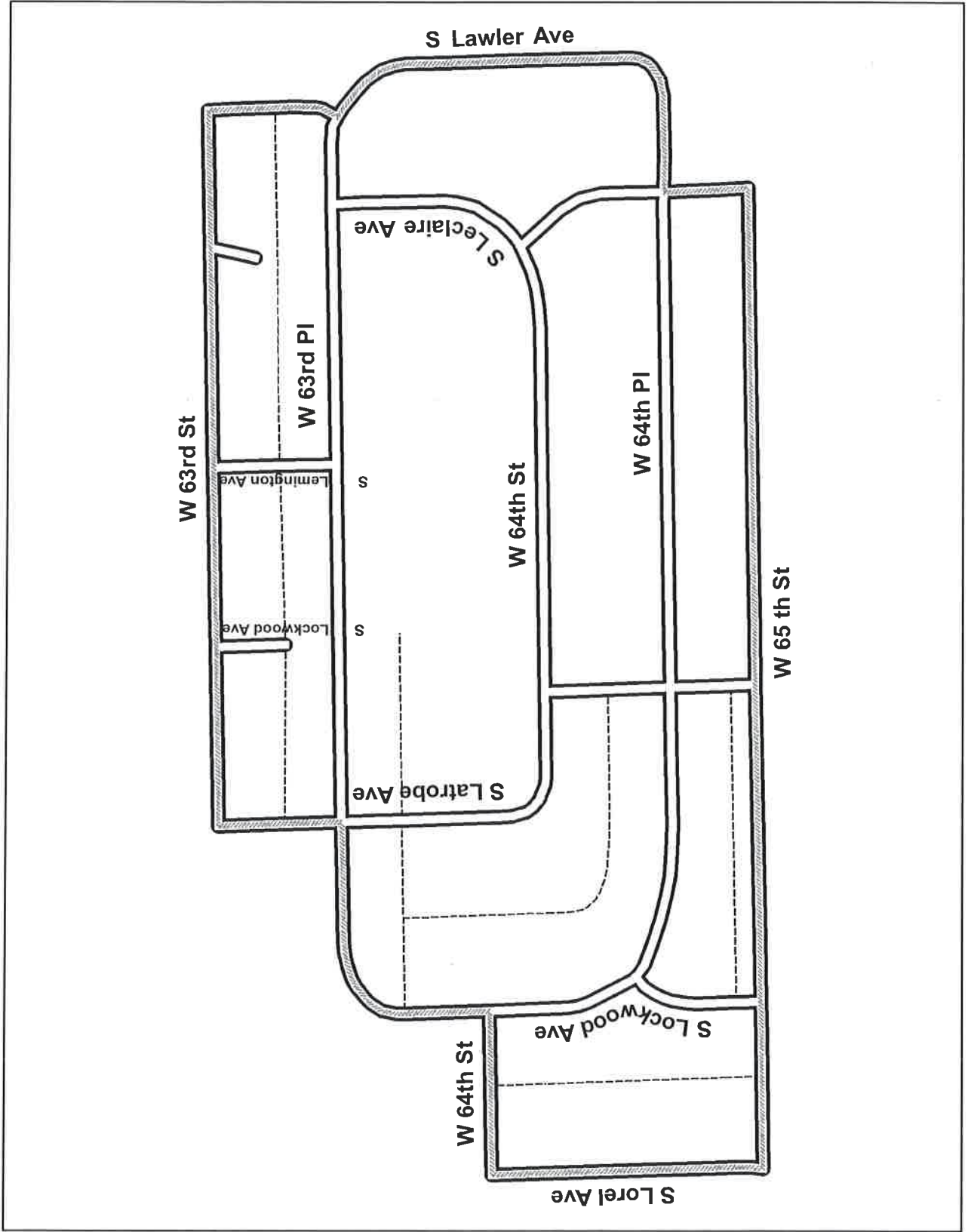
SECTION 2. This ordinance shall take full force and effect upon its passage and publication, and shall remain in effect for four years following its effective date.

Beginning at the intersection of S. Lockwood Av. and W. 63rd Pl., thence east on W. 63rd Pl. to S. Latrobe Av., thence north on S. Latrobe Av. to W. 63rd St., thence east on W. 63rd St. to S. Lawler Av., thence southerly on S. Lawler Av. to W. 64th Pl., thence west on W. 64th Pl. to S. Leclaire Av., thence south on S. Leclaire Av. to W. 65th St., thence west on W. 65th St. to S. Lorel Av., thence north on S. Lorel Av. to W. 64th St., thence east on W. 64th St. to S. Lockwood Av., and thence north on S. Lockwood Av. to the place of beginning.
