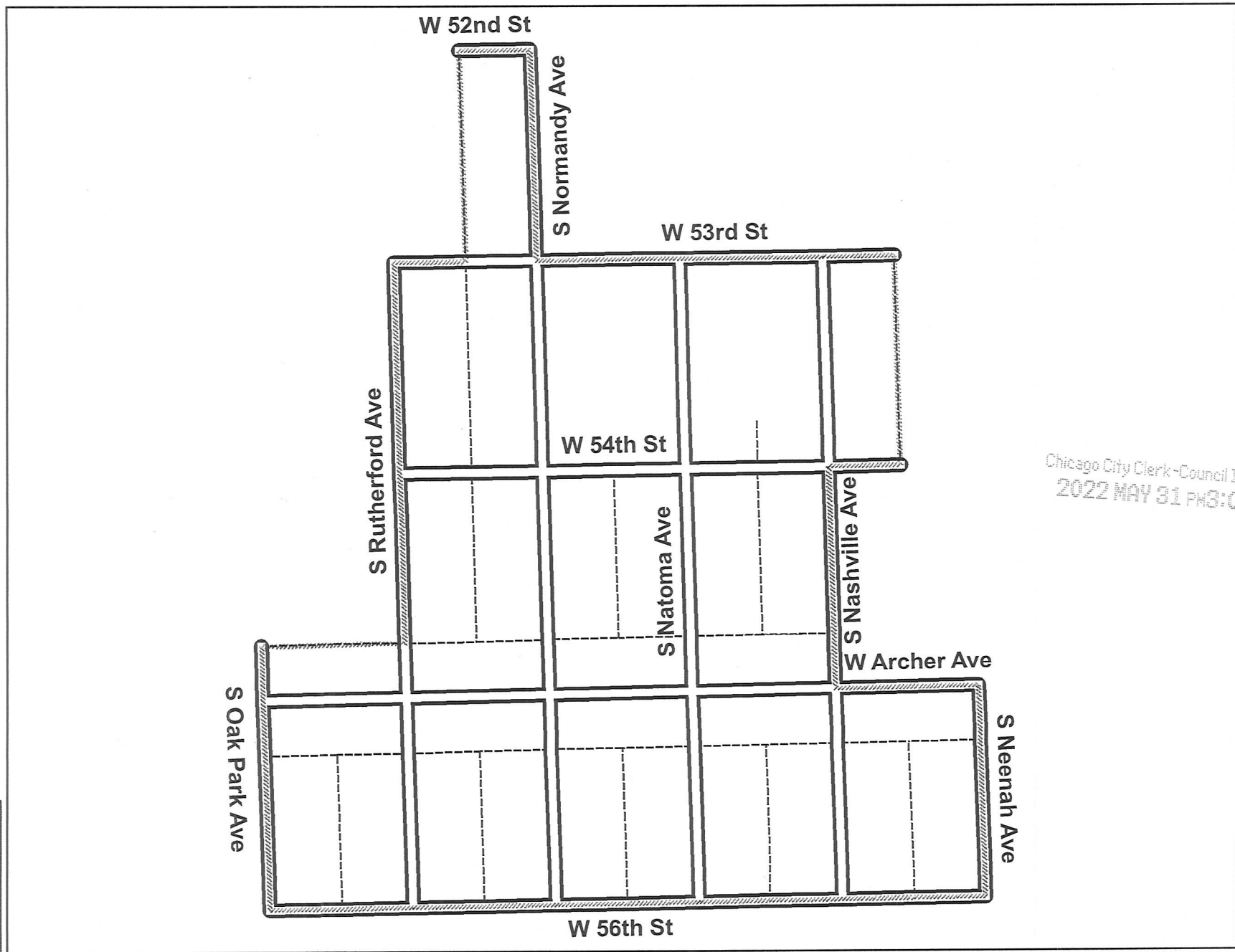

Nashville Av. to W. 54<sup>th</sup> St., thence west on W. 54<sup>th</sup> St. to S. Nashville Av., thence south on S. Nashville Av. to W. Archer Av., thence east on W. Archer Av. to S. Neenah Av., thence south on S. Neenah Av. to W. 56<sup>th</sup> St., thence west on W. 56<sup>th</sup> St. to S. Oak Park Av., thence north on S. Oak Park Av. to the alley north of W. Archer Av., thence east on the alley north of W. Archer Av. to S. Rutherford Av., thence north on S. Rutherford Av. to W. 53<sup>rd</sup> St., thence east on W. 53<sup>rd</sup> St. to the alley west of S. Normandy Av., and north on the alley west of S. Normandy Av. to the place of beginning.
