Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


Section 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RT-4 Two Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 10-F in the area bounded by

South State Street; West 47th Street; South Dearborn Street (including the Vacated portion thereof); and vacated West 46th Street

To hose of a B1-1 Business District and a corresponding use district is hereby established in the area above described.

Section 1. This ordinance shall be in force and effect from and after its passage and due publication.

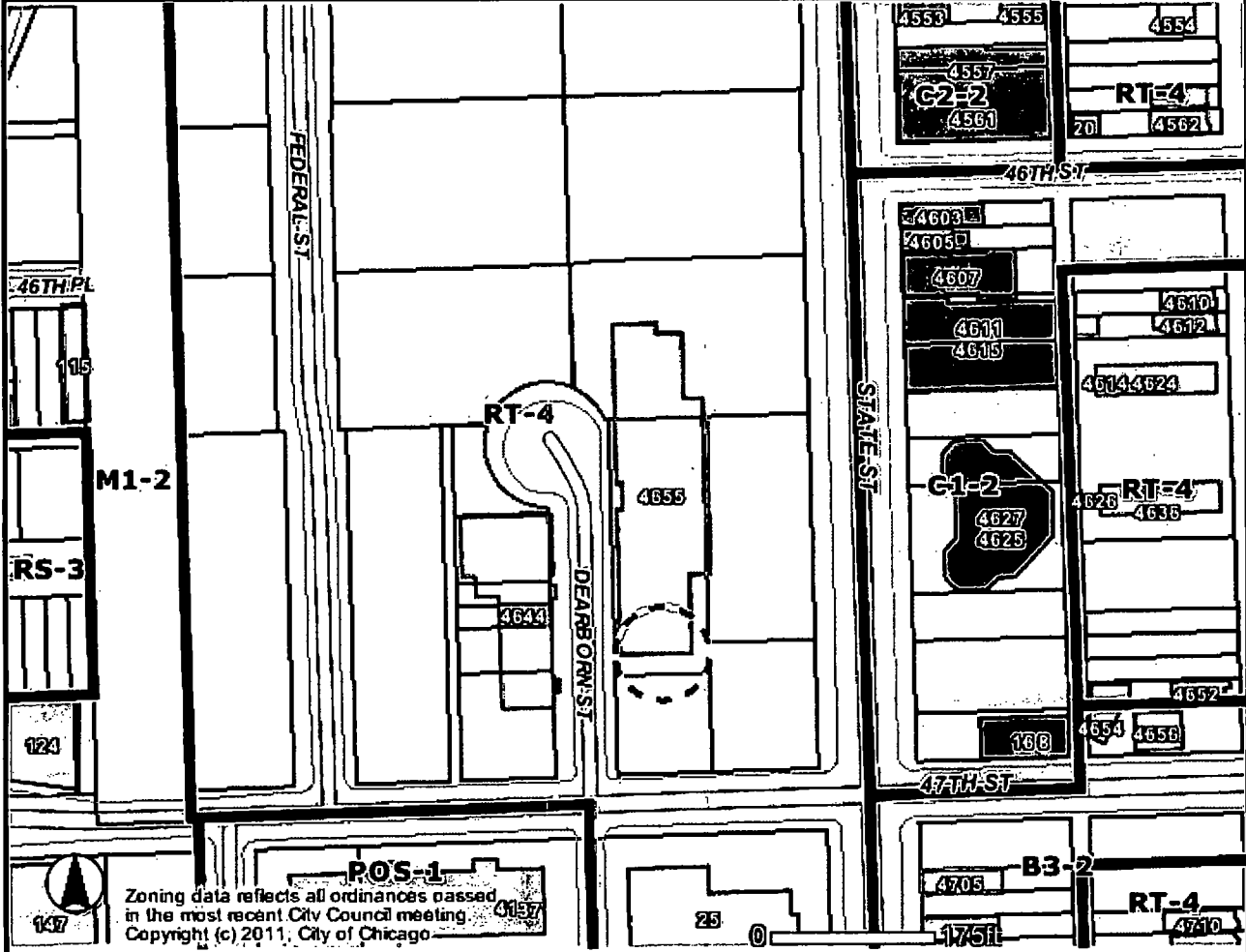
