COMMITTEE MEETING HELD ON September 22, 2021

In compliance with Governor Pritzker's Executive Orders 2020-7, 2020-10, and 2020-18, attendance at the meeting was held by remote means only.

Chairman Villegas called the meeting to order at 11:05 A.M.

Roll Call

The following members of the Committee were present as determined during roll call: Aldermen Villegas, Mitchell, Sawyer, Harris, Lopez, Tabares, Scott, Reboyras, Mitts, Sposato, Vasquez, Tunney, and Curtis. With 13 members present, quorum was established.

Approval of September 2021 Rule 45 Report (Monthly Report)

There were no corrections or comments. Alderman Lopez motioned to approve the report by the same vote as was used to determine quorum.

- Chairman Villegas asked if any of the appointees or reappointees would like to make a statement.
 - No appointees or reappointees made comments.
- Chairman Villegas asked if there were any questions for members of the Committee.
 - Ald. Tunney asked for clarification on SSA 23 as it was stated that it was in Wards 43 and 44, however he stated that for the record it is not located in Ward 44.
- Chairman Villegas acknowledged Alderman Tunney's statement and asked if there were any other questions for the members.
 - Alderman Cardenas requested that he be added onto the roll, and Chairman Villegas asked his staff to do so.
 - At this point SSA Reappointee, Amena Karim, raised her hand to speak and thanked the Committee for the continued opportunity to serve the South Shore community. She mentioned that there is still work to do with regard to advancing equity on the South Side of Chicago and driving business activations along certain corridors.
- Chairman Villegas stated that the Committee values the contributions commissioners make and thanked them for their willingness to serve.
- Seeing no additional hands raisedB, Chairman Villegas requested a motion for approval by the same roll call vote as was used to determine quorum.
- Alderman Tunney motioned and the motion was carried without objection.
- Chairman Villegas thanked the Commissioners and stated that the Committee looks forward to working with them.

Tax levy, budget and service provider agreement for Special Service Area No. 38, Northcenter Commission (Year 2021).

- Chairman Villegas asked if any members of the Committee had questions.
- No questions by committee members were made.
- Chairman Villegas asked if Mark Roschen from DPD (Department of Planning and Development) wanted to speak or make a comment on this matter.
 - Mark Roschen from DPD stated that he had no specific feedback regarding this matter, but advised that this is the first of fifty-four SSA budget ordinances that would be coming before the Committee. Additionally, he stated that each of the budgets has gone through a review process with the Office of Budget Management, Law Department, and DPD, and that they were developed locally at each SSA commission. Lastly, any Alderman impacted by these SSAs has been notified.
- Chairman Villegas thanked Mr. Roschen and requested a motion to recommend passage by the same roll call vote as was used to determine quorum.

Public hearing(s) on establishment of Special Service Area No. 52-2021, determination of tax levy rate, taxable area and selection of special services for area known as E 51st Street, from approximately Dr. Martin Luther King Jr. Drive west to Metra Railroad tracks

- Chairman Villegas asked if any members of the Committee had questions.
- Alderman Tunney had a question for Mark Roschen.
- Alderman Tunney asked when establishing a new SSA, what is the process to establish a public hearing?
 - Mark Roschen stated that there is an application process. For proposed SSAs 77 and 79, the applications were submitted last November to DPD. Part of the application process requires holding two community meetings as well as gathering signatures of support from 20% of the PINs from the proposed boundaries. All six of the SSAs discussed at this Committee meeting have gone through this process. Moreover, DPD does work in conjunction with the local aldermen and has support for all six hearings.

The public hearing itself is the final step and is mandated by the State of Illinois's SSA Statute.

- Alderman Tunney asked if Mark knew of the genesis/catalyst to establish SSAs.
 - Mark responded that many times it comes from the local chamber of commerce to help enhance commercial activity in the area.
- Alderman Tunney asked what are the three pillars of?
 - o Mark Roschen responded that they are 1. Clean, 2. Green, 3. Safe
- Alderman Tunney asked if the City has ever ended SSAs, and what is the process?
 - Mark Roschen stated that SSAs have been ended, and that is done through failing to vote on a budget for the SSA for the following year.
 Further, all SSAs have an expiration date, hence if no further action is taken to extend their term, it ends.
 - Additionally, there could be a formal termination of the ordinance, or simply failing to pass budgets.
- Alderman Tunney asked if SSAs are still collecting money unless they expire?
 - Mark Roschen stated that the only dollars levied are ones based on an annual budget ordinance, if no ordinance exists then there is nothing to levy against those PINs. This is also why it is important that ordinances are heard and approved by December, which is then filed with the County.
- Chairman Villegas asked if there were any additional questions. As there were none, Chairman Villegas used Alderman Reboyras's earlier motion to recommend passage by the same roll call vote as was used to determine quorum.
- The motion carried with no objection.
