Chairman Sawyer called a meeting to order at 1:05 PM. Chairman Sawyer stipulating the Committee on Health and Human Relations is called to order. Pursuant to applicable law, the Chairman had determined that an in-person meeting was not practical or prudent. Chairman stated that we have six items on the agenda the first is the Monthly 45 Report for August 2021 and the second, third and fourth item is the two appointments of Karen Hernandez and Steven Herman and one reappointment of Megan A. Chairman Sawyer introduced Alderman Maldonado

Alderwoman Rodriguez Sanchez, Alderman Cardona, Alderman LaSpata, Alderman Sigcho Lopez, and Chairman Sawyer all support this resolution.

Alderman Maldonado thanked the Chairman for allowing this resolution to be heard. Rodriguez Sanchez so moved the resolution. Chairman Sawyer thanked everyone.

Chairman Sawyer stated that the last item on the agenda is a subject matter hearing to discuss the City's co-responder pilot and non-law enforcement responder, pilot.

The guest speaker on this item is Matt Richards from the Chicago Department of Health. Matt Richards and Alex Heaton presented a PowerPoint of the different types of Model Pilots Alderwoman Rodriguez Sanchez asked about the Co-Responder Model Pilot program updates, Alex Heaton answered by referring to the Crisis Engagement response and Engagement (CARE) program, Alex explained the process of the model and that this is something new for the City of Chicago. Alderwoman Rodriguez Sanchez emphasizes the need for more treatment on Trauma and Alderman Cappleman spoke about his own experiences with Mental Health within his family, Alderwoman Hadden commented that she is excited to see the work that is currently being done with the Co-responder Model but that she shares the same sentiment as Alderwoman Rodriguez Sanchez related to police involvement. Alderman Martin asked how long it will take to provide the necessary data once the Co-Responders Model is in place. Matt Richards replied by saying that they would like to have a live dashboard to keep track of the data and have it on the website for the public to view.
