Chairman Sawyer called a meeting to order at 1:05 PM. Chairman Sawyer stipulating the Committee on Health and Human Relations is called to order. Pursuant to applicable law, the Chairman had determined that an in-person meeting was not practical or prudent. Chairman stated that we have two items on the agenda the first is the Monthly 45 Report for January 2022 and the second item is R2022-72 Affirmation of City's support for independence, sovereignty and territorial integrity of Ukraine.

Chairman Sawyer had a roll call to establish a quorum.

Chairman Sawyer opened the floor for public comments. There are no public speakers at this time. As the Chairman stated earlier, voted for the approval of the January 2022 by the affirmative vote of all the members present for the roll call to determine a quorum. So moved by Vice Chairman Cappleman, hearing no objection, so ordered.

Chairman Sawyer introduced the following item **R2022-72**-Affirmation of City's support for independence, sovereignty and territorial integrity of Ukraine. Chairman Sawyer introduced Nubia William (Director of New America) to speak on behalf of the resolution. Vera Eliashevsky also spoke on behalf of the resolution. Alderman Vasquez thanked the Mayor for presenting the resolution on Ukraine. Alderman Vasquez and Alderwoman Smith are both in support of the Ukraine community. Alderman Waguespack and Alderman Hopkins are also in support of the Ukraine families in Chicago and homeland. So moved by Alderman O'Shea, hearing no objection, so ordered.

Chairman Sawyer thanked the presenters and shared his concerns about Ukraine and the importance of supporting the country's independence.

There being no further business before the Committee, can I get a motion to adjourn by the same roll call vote as was applied to determine quorum? Alderwoman Hadden so moves. Hearing no objection, so ordered. The meeting of the Committee on Health and Human Relations is adjourned at 1:25 pm.
