Item 1 A2021-172 - Appointment of Andrea Kersten as Chief Administrator of Civilian Office of Police Accountability

Chairman Taliaferro introduced the agenda item before the committee. Chairman Taliaferro acknowledged that an item was sent to all council members on February 8, 2022 and accepted said item, Amendment of Section 2-78-145 of the Municipal Code, by direct introduction into the committee. The Chairman recognized the nominee, Andrea Kersten, who gave an opening statement. Chairman Taliaferro opened the floor for questions and comments by the committee and council members. The Chairman recognized Alderman Lopez who made a motion to "call the item to question." Alderman Taliaferro stated that he wanted to allow those present to participate in discussion and asked that Alderman Lopez withdraw his motion. After being recognized. Parliamentarian Jeff Levine stated that he was not sure if that motion was permitted outside of City Council. Item 7 SO2021-4130 Amendment of Municipal Code Title 8 by creating new Chapter 8-6 titled "Victims Justice Ordinance" to create civil remedy against street gang predatory and profit-driven practices
