REPORTS AND COMMUNICATIONS FROM CITY OFFICERS.

Placed on File--MAYORAL VETO OF ORDINANCE AMENDING CHAPTER 17,
SECTION 17-6.2 OF MUNICIPAL CODE CONCERNING SANITARY
LANDFILL SITES, ETC.

Honorable Harold Washington, Mayor, submitted the following communication, which was *Placed on File*:

To the Honorable, The City Council of the City of Chicago:

LADIES AND GENTLEMEN--On February 24, 1984, the City Council passed an ordinance amending Section 17-6.2 of Chapter 17 of the Municipal Code to require a City Council Order before any permit is issued for a sanitary landfill site, liquid waste handling facility or transfer station by the Commissioner of Consumer Services.

The issuance of permits pursuant to the provisions of the Municipal Code is an executive, administrative function. To require a City Council Order as a condition precedent to acquiring a permit would improperly interpose the legislative branch of government in the administrative process.

Consequently, I withhold my approval of this ordinance.

Re-Referred--PROPOSED ORDINANCE AUTHORIZING ISSUANCE OF
CITY OF CHICAGO GENERAL OBLIGATION DAILY TENDER NOTES,
SERIES 1984A, 1984B, and 1984C.

Alderman Burke moved to *Suspend the Rules Temporarily* to go Out of the Regular Order of Business for the purpose of considering an ordinance under Unfinished Business. The motion *Prevailed*.
