The following is said proposed resolution:

WHEREAS, Keith Caldwell, Alderman of the 8th Ward, departed this life on May 6, 1990; and

WHEREAS, Alderman Caldwell was first elected to the City Council in 1987, and was a diligent and proud servant of his community; and

WHEREAS, Alderman Caldwell served with distinction as Chairman of the Committee on Zoning from July, 1988 to April, 1989, and as Chairman of the Committee on Energy, Environmental Protection and Public Utilities from April, 1989, until his untimely death; and

WHEREAS, Prior to his election, Alderman Caldwell had served in the Circuit Court of Cook County as director of the Release on Recognizance Program and as a jury supervisor; and

WHEREAS, Alderman Caldwell is fondly remembered by his colleagues as a vigorous debater, whose ready wit and good humor often reduced tensions in City Council proceedings; and

WHEREAS, Alderman Caldwell is also remembered for his mellifluous voice, with which he entertained his colleagues by songs and recitations from literature; and

WHEREAS, Alderman Caldwell is survived by his beloved wife, Barbara and their children, Lori and Keith; and

WHEREAS, All who worked with Alderman Caldwell will recall with sincere appreciation his dedication to his office and the people of Chicago; now, therefore,

Be It Resolved, That we, the Mayor and members of the City Council of the City of Chicago, assembled this 16th day of May, 1990, do hereby mourn the passing of our dear friend and colleague, Keith Caldwell, and extend our most sincere condolences to his wife and family; and

Be It Further Resolved, That suitable copies of this resolution be presented to the family of Alderman Caldwell as a sign of our sorrow at their loss and of our esteem for our friend and colleague.

Mayor Daley stated that with the death of Alderman Keith Caldwell, the City Council had lost an esteemed, dedicated and hard working member. While noting that Alderman Caldwell loved the City Council and its debates, the Mayor observed that Alderman Caldwell was a peace maker and practitioner of the arts of negotiation and compromise. Mayor Daley also spoke of Alderman Caldwell's commitment to his family and church, remembering their preeminence in the Alderman's public and private lives. After acknowledging the long and distinguished career of the Caldwell family in the business as well as the political life of the city, Mayor Daley stated that Alderman Caldwell was a true role model for every citizen of Chicago. Speaking on behalf of the Daley family and the people of Chicago, Mayor Daley then expressed his condolences to the family of Alderman Keith Caldwell and the residents of the eighth ward.
