Rules Suspended -- RESOLUTION IN MEMORY OF THE HONORABLE THOMAS W. CULLERTON, ALDERMAN OF THE THIRTY-EIGHTH WARD.

The Honorable Richard M. Daley, Mayor, submitted the following communication:

LADIES AND GENTLEMEN -- I transmit herewith a resolution honoring the life and memory of our friend and colleague, Thomas Cullerton, Alderman of the 38th Ward.

The following is said proposed resolution:

WHEREAS, Almighty God in his infinite wisdom and mercy called Thomas W. Cullerton to his eternal reward on February 24, 1993; and

WHEREAS, Thomas Cullerton was Alderman of the 38th Ward of the City of Chicago from 1973 until his death; and

WHEREAS, Prior to his membership in the City Council, Alderman Cullerton served as chief electrical inspector of the City of Chicago, as a supervising electrical inspector, and as an electrical mechanic and estimator; and

WHEREAS, A lifelong resident of Chicago, Alderman Cullerton recognized the benefits that organized labor has achieved for the City of Chicago and its residents, and was a proud member of the International Brotherhood of Electrical Workers, Local 134 and spokesman for organized labor throughout his legislative career; and

WHEREAS, Alderman Cullerton was recognized by his colleagues as a diligent worker, who was often sought for advice and counsel because of his straightforward manner and trustworthiness; and

WHEREAS, During his tenure in the City Council, Alderman Cullerton earned a reputation as a champion of working men and women, and as a

strong proponent of economic development for his community; and

WHEREAS, Alderman Cullerton is survived by his wife, Betty; their son, Timothy; their daughters, Denise Thuis, Diane Devereux, and Patricia Cullerton; and their ten grandchildren; and

WHEREAS, Alderman Cullerton's quiet strength, his diligence, and his dedication to his community and to the City are an inspiration to all Chicagoans, and all of Chicago feels the loss of this gentle man; now, therefore,

Be It Resolved, That we, the Mayor and members of the City Council of the City of Chicago, assembled this eighth day of March, 1993, do hereby honor the life and memory of our friend and colleague, Thomas W. Cullerton, and we mourn his passing from our midst; and

Be It Further Resolved, That suitable copies of this resolution be presented to the family of Alderman Cullerton as a token of our sympathy and good wishes.

REMARKS BY THE HONORABLE RICHARD M. DALEY.

Daley, Mayor, rose to express his sympathy and condolences, on behalf of the Daley family and the people of Chicago, to the family of Alderman Thomas Cullerton. Lauding Alderman Cullerton as a bastion of stability and integrity, Mayor Daley remembered him as an individual who quietly and effectively labored on behalf of the residents of the 38th Ward as well as all the people of

Chicago. Alderman Cullerton excelled in, but most importantly was able to balance, his many roles within his family, his church, the labor movement and as a public official, the Mayor declared and asked the young people of Chicago to use as a model for their lives Alderman Cullerton's focus on and commitment to family, church, community and city.
