*Rules Suspended --* AMENDMENT OF TITLE 2, CHAPTER 8 OF MUNICIPAL CODE  
CONCERNING REDISTRICTING OF CITY WARDS.

[SO2012-582]

Alderman Burke moved to suspend the rules temporarily for the purpose of considering a proposed substitute ordinance, co-sponsored by Aldermen Mell, Burke and others, amending Title 2, Chapter 8 of the Municipal Code of Chicago concerning the redistricting of the wards of the City of Chicago and to permit a court reporter the privilege of the floor.

Alderman Fioretti raised a point of order stating that the call for the special meeting specified the items to be considered and therefore the motion to suspend the rules was not appropriate under Robert's Rules of Order.

Alderman Burke stated that City Council convenes in accordance with the operating procedures contained in its duly adopted Rules of Order and Procedure and to dispense with such procedures requires a suspension of the rules.

The Chair then ruled that Alderman Fioretti's point of order was *Not Well Taken* and upon hearing no appeal from the decision of the Chair, the motion to *Suspend the Rules Prevailed*.

Alderman Mell then presented for consideration a proposed substitute ordinance co-sponsored by Aldermen Mell, Burke and others.

Alderman Fioretti and Alderman Sposato moved to defer and publish the said proposed substitute ordinance.

Alderman Burke moved to lay on the table the foregoing motion by Alderman Fioretti and Alderman Sposato to defer and publish.

The Chair ruled that the motion to defer and publish was not in order, because under Illinois law it is applicable only to a report of a committee and not an aldermanic introduction of an ordinance, and upon hearing no appeal from the decision of the Chair, the motion *to Lay on the Table Prevailed*.

Thereupon, on motion of Alderman Mell, the said proposed substitute ordinance was *Passed* by yeas and nays as follows:

Alderman Pope moved to reconsider the foregoing vote. The motion was lost.

The following is said ordinance as passed:

WHEREAS, Article VII-Section 6(a) of the Constitution of the State of Illinois provides that a home rule unit of government may exercise any power and perform any function relating to its government and affairs; and

WHEREAS, The City of Chicago, having a population in excess of twenty-five thousand (25,000) is a home rule unit; and

WHEREAS, The redistricting of the wards of the City of Chicago is a matter relating to the government and affairs of the City; and

WHEREAS, Pursuant to Section 65 ILCS 20-21/38 of the Illinois Compiled Statutes, the City Council shall, by ordinance, redistrict the City of Chicago on the basis of the national census of the preceding year; now, therefore,

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Chapter 2-8 of the Municipal Code of the City of Chicago is hereby amended by deleting therefrom Sections 2-8-300 through 2-8-810 and substituting therefor new Sections 2-8-300 through 2-8-810, as follows:

2-8-300. Wards Created -- Basis -- Redistricting.

The City is hereby divided into 50 wards and redistricted as provided in this chapter.

In the year following the national decennial census, the City Council shall redistrict the City on the basis of such census. In the formation of wards in such redistricting, as nearly as practicable, each ward shall be compact, contiguous, and of substantially equal population with an acceptable deviation to respect established communities of interest or to achieve other legally valid and permissible objectives. This provision shall be subject to Section 21-39 of the Revised Cities and Villages Act, provided that no substitute redistricting ordinance shall be submitted to the voters pursuant to Section 21-39 unless one-fifth or more of the aldermen elected, who did not vote to pass the first proposed redistricting ordinance, file with the City Clerk a substitute ordinance together with an appropriate petition signed by them and any other provision to the contrary notwithstanding.

2-8-310 First Ward.

#### Redistricting Impact Statement.

The proposed map satisfies the requirements of the United States Voting Rights Act, the United States Constitution and the Illinois Constitution in that this map provides fair and equal opportunity for minority residents of the City of Chicago to elect representatives of their choice. The map creates eighteen (18) wards in which a majority of the total population is African-American and thirteen (13) wards in which a majority of the total population is Hispanic. In four (4) wards, moreover, no racial group or language minority group constitutes a population majority; minority communities combine to form a majority in each of these four (4) wards.
