Call To Order.

On Monday, November 14, 2022 at 9:00 A.M., the Honorable Lori E. Lightfoot, Mayor, called the City Council to order. The Clerk then called the roll of members and it was found that there were present at that time: Aldermen La Spata, Harris, Sadlowski Garza, Quinn, Moore, Maldonado, Burnett, Waguespack, Villegas, Vasquez, Reilly, Martin, Osterman, Hadden -- 14.

Mayor Lightfoot noted that there was no quorum present.

Thereupon, in the absence of a quorum, Alderman Waguespack moved that the City Council do adjourn. The Clerk called the roll and the motion to adjourn was lost by yeas and nays as follows:

Yeas -- Aldermen Harris, Ervin, Waguespack -- 3.

Nays -- Aldermen La Spata, Sadlowski Garza, Quinn, Moore, Sigcho-Lopez, Maldonado, Burnett, Rodriguez-Sanchez, Ramirez-Rosa, Villegas, Vasquez, Reilly, Martin, Hadden -- 14.

Alderman Hadden thereupon moved that the City Council stand in *Recess* until 9:30 A.M. The motion *Prevailed*.

At the conclusion of the recess, the Honorable Lori E. Lightfoot, Mayor, called the City Council to order.

The Clerk called the quorum roll call and it was found that there were present at that time: Aldermen La Spata, Hopkins, King, Harris, Sadlowski Garza, Quinn, Moore, Sigcho-Lopez, Maldonado, Burnett, Ervin, Waguespack, Rodriguez-Sanchez, Ramirez-Rosa, Villegas, Vasquez, Reilly, Martin, Osterman, Hadden -- 20.

Mayor Lightfoot noted that there was no quorum present.

Alderman Hadden thereupon moved that the City Council stand in recess until 11:30 A.M.

The Chair stated that because a meeting quorum was not achieved on two prior roll calls and given the start time set forth in the call for a special meeting, the motion to recess is denied and that the meeting is adjourned.

Alderman Ramirez-Rosa noted that pursuant to Rule 2 of the City Council's Rules of Order and Procedure, in the absence of a quorum the City Council members present are competent to recess the meeting by a majority vote.

Alderman Hadden then moved to appeal the ruling of the Chair.

The Chair then reconsidered her previous ruling and stated that the motion to stand in recess until 11:30 A.M. was now before the body.

The Clerk called the roll and the motion to *Recess* until 11:30 A.M. *Prevailed* by yeas and nays as follows:



At the conclusion of the recess, Alderman Reilly, President Pro Tempore, called the City Council to order.

The Clerk called the quorum roll call and it was found that there were present at that time: Aldermen La Spata, Hopkins, King, Sawyer, Sadlowski Garza, Quinn, Lopez, Coleman, Moore, Taylor, Rodriguez, Sigcho-Lopez, Maldonado, Burnett, Ervin, Waguespack, Rodriguez-Sanchez, Ramirez-Rosa, Villegas, Vasquez, Reilly, Martin, Osterman, Hadden, Silverstein -- 25.

Thereupon, in the absence of a quorum, Alderman Lopez moved that the City Council do *Adjourn*. The motion *Prevailed* by a voice vote and the City Council *Stood Adjourned*.
