Failed To Pass -- AMENDMENT OF 2023 -- 2027 RULES OF ORDER AND PROCEDURE FOR REMOVAL OF ALDERPERSON BYRON SIGCHO-LOPEZ AS CHAIR OF COMMITTEE ON HOUSING AND REAL ESTATE.

Following debate on the resolution, Alderperson Fuentes moved to call the question for a vote on the resolution noticed in the call for the special meeting.

The Chair asked Alderperson Fuentes to reconsider her motion to allow two additional members of the City Council to speak on the matter. Alderperson Fuentes thereupon withdrew her motion.

After further debate on the resolution, Mayor Johnson noted the presence of former 11th Ward Alderman James Balcer in the Commissioners' gallery and requested leave of the body to allow the former alderman the privilege of the floor to address the City Council. Hearing no objection, Alderman Balcer proceeded to thank the members of the City Council

for their impassioned debate and proclaimed his personal beliefs and respect for the American flag and its symbolic importance. Remembering his own military service, Alderman Balcer spoke of the 18,000 Vietnam veterans from Illinois who paid the ultimate sacrifice in service to the United States and the mournful homecoming they received in flag-draped caskets. We must remember and honor their service, Alderman Balcer asserted, and expressed his appreciation to Mayor Johnson for his support of the recently completed Vietnam Veterans Memorial restoration project. Thanking and memorializing the thousands of selfless veterans who served our nation in World War I and World War II, Alderman Balcer spoke of the members of his family who honorably answered the call to duty and recalled the sorrowful passing of his mother, his brother and his grandfather and the flag that proudly draped their caskets. The American flag is not merely a piece of cloth, Alderman Balcer stated, and it should not be burned under any circumstance.

At this point in the proceedings, Mayor Johnson recognized Alderperson Ervin who spoke on the resolution and thereafter moved the previous question.

Alderperson Lopez noted that a motion to adopt the resolution was not previously presented to the body and therefore he moved to adopt the proposed resolution.

The clerk called the roll and the proposed resolution *Failed to Pass* by yeas and nays as follows:

Alderperson Dowell moved to reconsider the foregoing vote. The motion was lost.

Said resolution, which failed to pass, reads as follows:

WHEREAS, The City Council of the City of Chicago has adopted its 2023 -- 2027 Rules of Order and Procedure; and

WHEREAS, Rule 36 of the 2023 -- 2027 Rules of Order and Procedure all for the members of the City Council to adopt a resolution codifying standing committee membership and leadership; and

WHEREAS, The City Council has entrusted to Alderperson Byron Sigcho-Lopez to serve as Chair of the Committee on Housing and Real Estate for the 2023 -- 2027 term; and

WHEREAS, Recent actions by Alderperson Byron Sigcho-Lopez call into question his judgment and fitness to serve in that capacity; now, therefore,

Be It Resolved, That, in accordance with Rule 36 of the 2023 -- 2027 Rules of Order and Procedure, Alderperson Byron Sigcho-Lopez is hereby immediately removed as Chair of the Committee on Housing and Real Estate; and

Be It Further Resolved, That such removal will be effective immediately and that the Vice-Chair of the Committee on Housing and Real Estate shall assume leadership of the committee until the City Council of the City of Chicago installs a permanent Chair for the remainder of the 2023 -- 2027 term.

Adjournment.

Alderperson Dowell moved that the City Council do *Adjourn*. The motion *Prevailed* by a viva voce vote and the City Council *Stood Adjourned*.
