Pursuant to Rule 45 of the City Council Rules of Order, the Committee on Workforce Development submits the following Monthly Rule 45 Report for June 2023.

Date, Time & Location of Meeting: On June 12th, 2023 at 2pm the Committee met in the City Council Chambers.

Chairperson Rodriguez called the meeting to order at 2pm. There was only one item on the agenda, a Mayoral introduction, **O2023-1591**, an intergovernmental agreement with the Forest Preserve District of Cook County for land management services provided through Greencorps Chicago.


Chairperson Rodriguez had a roll call to establish a quorum.

Chairperson Rodriguez then noted that there were no public speakers scheduled for the meeting. The Chairperson then introduced agenda item **O2023-1591**, and presented Sean Wiedel, Deputy Commissioner for Citywide Services at the Chicago Department of Transportation to speak on the matter. Deputy Commissioner Wiedel provided a brief summary of the intergovernmental agreement and the benefits to the City and to the participants of GreenCorps. Chairperson Rodriguez then opened the floor to questions. Alderman Burnett spoke to the item and asked about recruitment to the GreenCorps program which Deputy Commissioner Wiedel addressed.

Chairperson Rodriguez then asked if there were any other members who had questions, and seeing none asked for a motion for passage of the item which was provided by Alderman Ramirez-Rosa by the affirmative vote of all members present used to determine quorum.

Chairperson Rodriguez then asked for a motion to end the meeting as there was no further business, which was moved by Alderman Guterrez. The meeting was adjourned at 2:11pm.
