Subject Matter Hearing / Committee Meeting - September 29, 2023

On September 29, 2023 at 9:00 AM, the Committee on Immigrant and Refugee Rights held a Subject Matter Hearing / Committee Meeting in the City Council Chambers, on the 2nd Floor of City Hall. The Subject Matter Hearing discussed the roles of the Office of the Mayor; Office of Emergency Management & Communications (OEMC); Chicago Police Department (CPD); and mutual aid groups in welcoming new arrivals.
