COMMITTEE ON PUBLIC SAFETY MONTHLY RULE 45 REPORT October, 2023

Pursuant to Rule 45 of the City Council Rules of Order, the Committee on Police and Fire submits the following monthly report.

On Friday, October 13th, 2023, at 1:08 p.m., The Committee on Police and Fire called the meeting to order, pursuant to applicable law, the Chairman determined that remote participation was allowed in case of emergency, per the aldermen that requested. Accordingly, attendance at this meeting was in City Council Chambers.
