COMMITTEE ON POLICE AND FIRE MONTHLY RULE 45 REPORT April, 2024

Pursuant to Rule 45 of the City Council Rules of Order, the Committee on Police and Fire submits the following monthly report.

On Monday, April 1st, 2024, at 10:24 a.m., The Committee on Police and Fire called the meeting to order, pursuant to applicable law, the Chairman determined that remote participation was allowed in case of emergency, per the aldermen that requested. Accordingly, attendance at this meeting was in City Council Chambers, with some members participating virtually.

The following members were present: Vice-Chairman Robinson (4), Hall (6), Mitchell (7), Curtis (18), Tabares (23), Cardona (31), Sposato (38), Napolitano (41), Gardiner (45), Silverstein (50), and Chairman Taliaferro (29).

The following members were absent: Knudsen (43), Clay (46).

The following members participated by remote means: Lee (11), Taylor (20), Mosley (21), Ervin (28), and Nugent (39).

The following non-members participated by remote means: Burnett (27) and Mitts (37).

The following additional Aldermen were present: Dowell (3), Beale (9), Chico (10), Lopez (15), Moore (17), Sigcho-Lopez (25), Vasquez (40), and Manaa-Hoppenworth (48).

Chairman Taliaferro called the meeting to order at 10:24 am. The Chairman Taliaferro instructed protocol to be used in the forum. Chairman Taliaferro read out the "Rules of Conduct for Public Meetings." Roll Call was taken and a quorum was established. The following members requested remote participation; Lee (11), Taylor (20), Mosley (21), Ervin (28), and Nugent (39). The motion to let the members participate remotely was so moved by Alderman Cardona. The Chairman opened the floor for public comments. Item 1 SO2023-0005726 – Amendment of Municipal Code section 2-152-410 by modifying mandatory retirement age for police officers

Chairman Christopher Taliaferro introduced the agenda item. He made a motion to accept the substitute before the committee. There were no objections, and the motion was ordered based on the affirmative vote of all members present for the roll call used to determine a quorum. The substitute is before the committee. The Chairman, as chief sponsor of the ordinance briefly explained the ordinance and opened the floor for questions.
