**Date, Time & Location of Meeting:**

On March 14, 2024, at 1:00 pm., the Committee on Public Safety held a meeting in City Hall, Council Chamber, in Chicago, Illinois.

Roll Call was taken and a quorum was established.

**Roll Call:**

**Public Comment:**

There were 2 public comment speakers: Taiwan Sims and George Blakemore and 1 written public comment from Janice Cody.

**The Committee addressed the following items:**

1. Approval of Rule 45 from December of 2023.

2. A2024-0007311: Appointment of Jose Tirado as Executive Director of Office of Emergency Management and Communications.


***Item number 2: A2024-0007311: Appointment of Jose Tirado as Executive Director of Office of Emergency Management and Communications.***

*Alderman Sposato made a motion due pass. Chairman Hopkins called for a voice vote on the item. All in favor indicated 'ay.' All against would indicate 'nay.' There were no 'nays.' The item passes. The item was reported out for the March 20th, 2024, City Council meeting.*
