The agenda consisted of the following items:

1. Approval of Rule 45 Report for January 2022

Motion to approve was made by Ald. Ervin, and Rule 45 Report was adopted unanimously by voice vote.

2. O2022-665/SO2022-665 - Amendment of Municipal Code Titles 2, 4, 6 and 8 by modifying and expanding sexual harassment prohibitions (Mayor Lightfoot) [PASSED]

Substitute ordinance SO2022-665 was accepted by the Committee. Public comment was allowed, and testimony was taken. Questions and statements were taken from aldermen present. Motion to approve the ordinance was made by Alderman Mitts, and the motion passed unanimously by voice vote.

3. Subject Matter Hearing on O2022-407/SO2022-407 - Amendment of Municipal Code Chapters 6-100 and 6-105 by modifying various sections and adding new Sections 6-100-040 and 6-100-050 regarding procedures for payment of wages, minimum and maximum salary stated in job listings, and establishment of fines and penalties (Ald. Villegas, La Spata)

Substitute ordinance SO2022-665 was accepted by the Committee. Public comment was allowed, and testimony was taken. Questions and statements were taken from aldermen present. No vote was taken, and the item was held in committee.
